




Q2 Do you live on or near (within walking distance for you) of the shore?




Q3 What is your age group?



Q4 Do you feel safe when going to and using our waterfront parks and public spaces?






Q6 Are there areas of the harbor where, because of congestion and other conditions, you feel that boating and navigation safety is reduced? If yes, please explain.






Q8 If you own a boat, where do you normally keep it during the boating season?




Q9 How important is boating in our harbor to you?








Q12 Overall, do you think the water quality in New London Harbor and the Thames River is:






Q14 Do you think the water quality is good enough to go swimming?




Q15 Are you aware of the pollution problems that can be caused when storm water runs off the land?

























Q30 Number and location of boat moorings

7	As a frequent walker of the city, I would like Fort Trumbull connected to the downtown waterfront with a pedestrian bridge. This would make both areas more accessible to me and others who enjoy walking. In addition, if public access to the waterways is important to the city, then it should be advertised and signed as aggressively as the bike pathways are. Lastly, downtown does not need more development at waterfront park, as this will only hurt the current businesses. More should be done at Fort Trumbull to diversify and maximize where tourists and locals can visit, shop, and eat.

11	would like public kayak/canoe launch somewhere in Alewife Cove
12	Parking can be a deterrent to using the waterfront especially at Greens Harbor Beach. Any development should include plenty of parking in a safe area.
13	The Connecticut government shouldn't be engaged in commerce itself, nor should it pick winners and losers be a gate keeper. Its primary objective should be to provide vital access to commercial waterfront assets to the largest number & widest variety of enterprises that a free market may offer or allow. This requires a set of simple, fair, and transparent rules for such a finite resource. It's about the development of a vibrant working waterfront economy, not a cash cow for governments, their agencies, or patrons & friends, which has been the trend in Connecticut since its adoption of the income tax. We're watching.
14	Putting a restaurant of City Pier is not a good idea it ties up an important public space & blocks the view; using one of the smaller piers would work better. The City Pier is needed for special events, public boating. Developing the potential park areas of the waterfront would create a destination. Seating groups and umbrellas, in season, would draw people with food from downtown to the waterfront and enliven the area.

- 15 I think the most important goal is to strive for a balance among competing interests and factors, among them commerce, public access and recreation, overall esthetics (i.e., appearance of the harbor and shorelines), and historic preservation wherever applicable.
- 16 I'm an advocate for the use of State Pier for the staging of wind farm components and servicing.
- 17 I would like a safe place to store my fiberglass kayaks on the waterfront Park. A few years back there were racks but I wouldn't be feel safe leaving them overnight state pier I am for wind farm development but not at the expense of use of rail I am interested in learning more about the staging area for building wind turbine equipment on a temporary basis which was turned down makes more sense than one company hogging the whole piece Of everyone else
- 18 New London, shore location and its developed amenities, like State Pier, are great resources that are underdeveloped. That must change. I am particularly concerned about wind development issues. We must not be robbed of our resources and legacy.
- 19 Protect our waterways and encourage shoreline organizations to work together for the benefit of all!
- 20 I get very discouraged reading about DEEP interfering in development. That should be the developers' problem and local authority.
- 21 Some of the questions just asked regarding concern could be taken a different way than perhaps intended. Concern could mean either that the subject of the question occurs too much or too little.
- 22 There is a tragic lack of public areas for swimming and general beach use, Ocean beach is financially inaccessible to many New London residents, and the only other option is greens harbor which is small dirty and full of broken glass
- 23 Access to the water and recreational opportunities to enjoy this amenity are some of the most important features that enhance the quality of life for residents and make the city appealing to new residents and businesses. The city should focus on conserving what little waterfront is available to be converted into publicly accessible areas. Parks and open space drive up real estate values and contribute to the economic and social prosperity of the city. Furthermore, public access to the water bridges the gaps in racial and social inequity that results from a privatized coastline and limited access to nature for the underserved populations.
- 24 More attention needs to be paid to stormwater runoff.
- 25 NL has to move forward and compete as a seaport city. We can't be held back by traditional perspectives.

- 27 Making shoreline facilities more accessible to disabled.
- 28 I would like to see more public use of the waterfront, like cardboard boat regattas and similar whimsical watercraft activities.
- 29 New London is a coastal city and needs to identify itself as friendly to families, residents and some tourists by having water views, clean water and good recreation opportunities. Being a deep water port, that is yet another attraction.
- 30 The waterfront park is like a desert open and barren. No charm, no picnic tables. Pretty much a dead zone. Needs a lobster pound and mooring launch service. Boats need to be docked there. A a walking bridge should be attached to the railroad bridge to connect walkways along the shoreline. Moorings should be free to transient boaters.
- 31 Question 21 did not have any answers I could agree with. I would like to see more commercial development of the waterfront however it shouldn't be "everywhere" and the term "water dependent" is too limiting. There should be more restaurants, bars and high end retail adjacent to/walking distance from the downtown piers. Paddleboarders, kayak rentals are commercial activities that could be developed. Could we host an international Kite Surfing competition? New London needs some classy events, New London Jazz Fest at Fort Trumbull (this will require transportation from the garage and revision of zoning constraints on noise). Ocean Beach should be redeveloped to support seasonal retail, multiple restaurants, and space should be carved out of their overflow parking area to allow for a new canoe put in on Alewife Cove. Ocean beach should develop a new pier and moorings similar to the one in the early 1900s. Ocean Beach should develop for year round assets, including an indoor pool. Ocean beach should rent kayaks and paddle boards. The minigolf and "rides" need to be reconstructed or demolished. Residency in NL should get you in free to Ocean Beach, the amenities can be the upsell (walk-in for NL residents). In Riverside Park, the pedestrian bridge should be redeveloped allowing access to the Thames River, for too long one of our greatest assets has been cut off from the public. Restore the Thames River ecology to the point where we can have shell fishing for both public and commercial interests. Educate paddle boaters about the cross current north of Ledge Light - there are few eyes-on-the-street there and paddle boarders in particular should be aware.
- 32 Dumping of waste fluids from cars, trucks, buses, BOATS, SHIPS and humans. I can't stand when I see other fluids that does not belong in the river and ocean floating or even a hint of anybody or company dumping

fluids or garbage and sitting or moving around at the bottom of the river or ocean.

33 GIVE THE PIER BACK TO NEW LONDON RESIDENTS AND SCREW OFF EVERSCOURCE

- 34 Move the coast guard museum to Ft. Trumbull.
- 35 New London should be a destination for boaters but it is most unfriendly. When the cruise ships come in the stores are closed. The customers are driven to other towns. Why not make new London more appealing to keep the cruisers in town.
- 36 The solution of a clean harbor will take years. Since it took years to make it dirty. Keep working on solutions...if not this generation, then the next will build on what we have started
- 37 Looking forward to the National Coast Guard Museum adding an important element to downtown. Also, cruise ships at Fort Trumbull!
- 38 We need more publicly accessible beach areas, that are free or drastically reduced in price for city residents. A large percentage of our citizens cannot afford to buy a share in a private beach or even afford the excessive cost to enter OBP, and thus we are excluding our children from some of the great joys of coastal living. I care about this more than boating.
- 39 Public beach access is very important to me. Many NL families simply cannot afford an Ocean Beach pass and Greens Harbor the only remaining option in town.
- 40 Plans that include public access should be limited to New London residents at no cost and non-residents for a fee. New London's taxpayers should not bear the burden of providing shoreline access to non-residents at our expense. The council should figure out a viable means to charge non-residents for access to areas when entry/parking can be charged for, similar to how Ocean Beach Park has a resident/non-resident fee structure. We have a gem of a city and should take steps to keep it affordable for the residents.
- 41 I would like to see a vibrant modern industrial site developed and good docking for more mega yachts to bring jobs and tourism. I don't want to see permanent restaurants on the docks. We have enough in down town within walking distance. I would like to see a walking and bike path and trolly to Fort Trumbull and put the Coast Guard Museum there. There is plenty of room near Fort Trumbull for development to enhance our water front. Good long term development is important because the tourist industry is seasonal and shouldn't interfere with the industrial development.

- 42 would like to see a restaurant on the harbor also more launching accessibility for kayaks
- 43 The proposed Coast Guard Museum is planned to be built within the restricted flood zone area. This is stupid and illegal. Do not build the museum behind the train station. Build it within the Fort Trumbull where the original Coast Guard Academy was located. Do not give in to bribery.
- 44 Responsible development needs to occur in order for New London to become a thriving vibrant city that people want to visit and move to
- 45 Coast Guard Museum better suited to Fort Trumbull. Not waterdependent and too massive for site on downtown waterfront.
- 46 Public beach access in New London is unacceptably poor, in my opinion. The one actual, free-to-use, public beach (Green Harbor Beach) is situated in a marina, and often shows signs of petrol pollution from nearby boats. It is hard to say whether it is safe, and I am unaware of whether the city leadership conducts water testing at this site. The location and condition of this one public beach is a disservice to the economically underprivileged and by extension all New Londoners, which in a town as diverse as this, is a real shame.
- 47 Development should be environmentally safe, with public access and financially benefit New London.
- 48 Even though the concerns of a new Harbor Commission would be different from those of the State Pier (the Port), I would hope that a separate group of people that would represent the actual users of the Thames River in the New London area would be tasked with this important commitment. This group should be by appointment for terms of 2-4 years, and the members should not serve on the Port Authority. No entity should have total control of this vital seaport area in New London.
- 49 What I always wanted to see in New London was a Merchant Marine Museum. This from the train station to the state pier. An interactive, working museum to include the ferry services, tugboat operations, Coast Guard Museum, and an operational merchant port. All connected along the waterfront. Just my thoughts, Joe Geraci, Stonington, CT
- 50 We need to develop our whole city and expand the tax base, but water access holds its value and can drive that development.
- 51 I think that supporting "offshore wind" is a great opportunity but I hate to see you lose the existing shipping. Could you make the west side of Admiralty pier usable?
- 52 New London needs to promote ship-to-rail commerce. There are two railroads (New England Central and Providence and Worcester) that have access to Class 1 railroads which in turn allows access to all of America, Canada, and Mexico. New London based intermodal services will be

attractive to ocean shippers not wanting to deal with the hassle of New York or Boston harbors where landing fees are high.

- 53 I think the New London Waterfront Park along Water Street should be directly connected via bike/ped bridge to the Fort Trumbull area. Coast Guard Museum should be sited at Fort Trumbull instead of near Union Station. I think Pequot Ave should be closed to cars every Sunday, April through November, from 10am to 4pm, to provide access to beautiful waterfront public space for leisure and fitness, biking, walking, jogging, I think the beaches along Pequot Ave and Ocean Beach should be etc. made available to New London residents for free to provide public access to the water for reasons of health, recreation, and social justice. We need more public bathrooms and water fountains. I do not know of any public bathrooms or water fountains. We really need more of them as a first step towards developing our town and our waterfront spaces. When people visit, they need access to clean, spacious bathrooms, including drinking fountains. They should be placed along the water from Riverside Park, to New London Water Front Park, at Fort Trumbull, Greens Harbor, along Pequot Ave, and at Ocean Beach. If you have to pay to get in, they are not equitably available, and not really public.
- 54 I am not originally from this area. Privately held beaches are an unfamiliar concept to me. I am absolutely appalled with the amount of beaches with restricted access. Somehow, over time, these beaches should be returned to some sort of public park system. Beaches should not be privately owned.
- 55 The entire waterfront should be publicly accessible. The notion of private beaches is exclusive and caters only to the rich. Also, the city should not allow development along the waterfront, for example the US Coast Guard Museum. It will block views of our historic train station and contribute to environmental issues. A much better place for the museum would be at Fort Trumbull, the city and the state owes it to the citizens of New London to do something good with that site and not ruin the few good things that remain.
- 56 None. A lot of constituencies to satisfy. Environmental issues should not dominate. No change driven by NI B Y residents will negatively impact the community. There are already instances of this in N L.
- 57 Pedestrian tie between downtown waterfront park and fort Trumbull should be priority. Planning for coastal resilience for predicted sea level rise and increased rainfall needs to be considered ahead of development planning.

58 Thank you. We love the waterfront and our access to it-it's why we're in New London! 59 I am very concerned about the pollution of the Thames River & Long Island Sound by Pfizer, EB, Sub Base, Dow Chem, CGA, Mohegan Sun continuously discharging raw sewage into our water, along with oil spills, pesticides, chemicals etc. causing high bacteria levels & algae in the sound. I doubt anything will be done to correct this problem. 60 NL must make use of its waterfront to attract people to come and invest in our city. I truly believe that development at State Pier is essential to New London's 61 health. I am very hopeful about the wind project. Would be nice for cruise ships to return to NL. The downtown waterfront 62 as such potential, but is disgusting with the drug use and vagrants. Make it nice and welcoming for visiting boaters. I hold no hope for this since NL screws up everything they do. New London waterfront: from north of Coast Guard to Ocean Beach is the 63 city's greatest geographic asset and the most underutilized asset. Folks all over the world pay \$\$\$ millions to have this kind of access to ocean and tributaries and New London's access is squandered due to lack of planning, action, and management of the total waterfront. Note about the survey: the boating question should not be just for boaters. Civilian boating is the canary in the coal mine when it comes a vibrant waterfront: lots of pleasure craft, lots of associated commerce. Little civilian boating: miles of underutilized waterfront property. The state boat launch under the Gold Star bridge is an ugly mess. It should be made into a "model" of amenities for pleasure boaters to attract 100s of new visitors to New London. How about kayak vendors at the launch area? 64 Walking access across Shaw Cove from Bank Street to Fort Trumbull via a "bridge" attached to the railroad bridge should be considered. It can open and close for walkers similar to how it opens for vessels using swing arms and lights like railroad crossings. We enjoying being near the New London Harbor & waterfront resources. 65 Love seeing the sailing vessels that are moored in the city, watching the Submarines ply the river & eating in restaurants that are near the railroad tracks & the ferry landings - PARTICULARLY MUDDY WATES CAFE! For the love of god can someone please address the sunken boat off of 66 Burrs Marina? Literally down since mid-January, this boat (as I've been told) is 100% "not our problem" due to it being outside the channel & not a navigational hazard. Well, let me tell you, as I literally look at it several times a day (I live on Harris Rd.) it's an embarrassment to the city. Everyone is aware (I'm 100% certain Mayor Passero & Dave Crocker

were made aware back in February) of it but because no one wants to absorb the cost, it sits. No repercussions for the uninsured owner, so it sits. And the biggest loser in this... the environment. In this day and age, with all the information & physical evidence about water pollution it should have been addressed without question. For everyone to be turning a blind eye is simply disgusting. Lastly, just because it's not in the channel doesn't mean it's not a hazard. I only hope, with the huge amount of boaters expected for the fireworks tonight, there are no injuries.

- 67 Preserve the historic Winthrop mill area as the state pier is re-purposed to support wind-generated power sources.
- 68 The State pier should be developed to accommodate cruse-ships and container ships and not be single use like windpower.
- 69 First the city failed when it tore all the buildings down by FT Trumbull the location of the Coast Guard museum should of been Near Fort Trumbull not pigeon holed to appease a few businessmen. Then if the city decides on a sting stance with crime, then and only then will down town flourish. Allowing companies to build on the water front, then restricting residents from that area, will not improve support of any projects. It has to provide access to the areas. Very little water front construction of commercial or residential needs 100% control of the shoreline.
- 70 A commuter ferry (probably 3 seasons) from Pequot marinas/Ft. Trumbull area over to Groton Bank/EB would be awesome, and get some cars off the road. We can see my husband's office at EB in Groton from our home off Thames St., but he can't ride the EB bus since he works for Sup. Ship. (Navy).
- 71 Preserving the environment should be the focus. New London has been constant in its foolishness by giving away its resources to companies that have zero investment in the community. New London needs to focus on the people and wildlife that are HERE now. Stop selling away our future.
- 72 The predictions of higher sea levels and severity of storm and tides puts any further development of waterfront at great risk. The public should not bear the costs of those risks while contractors profit from development.
- 73 Additional access to the walkway and expansion of the Thames River Heritage Park would be great.

74 Good Job. Good Luck. Time finally to realize New London's "Potential".

- 75 It is important to maintain waterfront views along Bank Street and Pequot Ave so people driving or walking by can see the river and all the wonderful activity that takes place along our shores.
- 76 Our New London port, waterfront, and coastal areas are extraordinary assets. We should take full advantage of these assets by expanding both

commercial and recreational development everywhere along our fantastic "shoreline."

- 77 I sincerely hope this forces the city to reconsider the practices of Ocean Beach. City residents living in the high poverty areas, more likely to be Black or Brown people, are isolated geographically and financially from the best beach in the region. There is no equitable access to the Pequot Avenue beaches either. Completely held hostage by millionaires who mostly only stay for the summer. Until we address the real issues of inequity, no development matters. If anything, we absolutely have to stop building luxury condos. Create middle class and affordable housing, interspersed with each other (poor people don't all have to live together). Develop our waterfront for the people that actually live here - free access to Ocean Beach, buy back our Pequot beaches and give access, create beach access as Riverside Park, and don't isolate our low income families to the cesspool of Green Harbor. Also, hold the Coast Guard accountable for dumping sewage for decades.
- 78 Not enough access to free local beaches!79 Conservation and eco-conscious decision
- 79 Conservation and eco-conscious decisions need to be in place for any and all waterfront use and development. New construction on or near the water needs to be very eco-conscious above all else! Destruction of our natural resources must be avoided.
