1) Who is going to carry the hygienist cost for asbestos abatement

The cost shall be carried by the GC or sub

2) The leaded items that are being removed do we consider it hazardous waste or C&D? In the paperwork provided in the leaded portion 3.2 Conclusion first paragraph says that the areas tested that are leaded, "contain TOXIC LEVEL OF LEAD BASE PAINT".

Contractor shall follow EPA lead safe work practices to protect workers and the environment. EPA RRP rule does not address disposal but DEP regulations stipulate disposal of debris contaminated with leaded components may be considered hazardous material depending on the amount disposed of per month. Contractor shall follow DEP regulations for small or large quantity generator if needed.

3) Assuming where note where we are to remove door and frames and not walls, from plaster walls, these will be needed to be done under containment as there is asbestos in the plaster correct and all plaster wall being removed these will be done under containment.

4) 4)- Up on the top floor where we are to remove a walls, some are solid wall, you will need to supply bracing or shoring as noted on the plans

APS Responses in blue

1) There was a substantial amount of water entering the basement mechanical room during my walk through. There is no reference to this condition or remediation work associated with this current problem.

We are aware of some water infiltration into the basement through the existing hatches. This should be addressed through the specified repair/replacement of the hatches

2) The existing site has a surface concrete drainage swale that will run into the new chiller pad on noted on drawing M-1. See attached photos. Drawing L-1 notes two lines.

The new chiller pad is located to the east of the existing drainage swale

3) Can the bid be extended to the week of January 23rd to account for the short week due to Monday's holiday and the need to review addendum # 6 when it is issued
