SMALL B.I.G. PROGRAM

Owners of a small business with a physical location in the city are invited to apply for a Business Improvement Grant of up to \$10,000 to help them sustain their business and remain resilient in the face of unforeseen challenges and during off-peak seasons. The Small Business Improvement Grants Program, or Small BIG, is administered through the New London Office of Economic Development and Planning with funding from the American Rescue Plan Act (ARPA).

This program is for small businesses that have existed in New London for at least one year and are in good standing with all local, state, and federal regulations and tax departments. The minimum award is \$2,000 and the maximum award is \$10,000. BUSINESS INCENTIVE PROGRAMS

FACADE IMPROVEMENTS

1. Building Facade Improvement Program. Provides grants up to a maximum of \$50,000 per single principal building in the downtown program area.

2. Downtown Sign Improvement Program. Provides grants up to \$1,999 to first- and second-floor storefront business owners for business signs, and for property owners for building identification signs.

REVOLVING LOAN FUND

1. Business Revolving Loan Fund. This program provides low interest loans for small- and medium-size businesses located within, or considering locating within, the New London Enterprise Zone (EZ).

2. Commercial and Mixed Use Building Rehabilitation Program. This program provides financial assistance to owners of commercial properties, located within the Enterprise Zone, who plan substantial building renovations.

CITY & TOWN DEVELOPMENT ACT

A special tax exemption program available for major capital improvement projects that create long-term, tax-based growth. This program may not be available for projects eligible for Enterprise Zone programs.

ENTERPRISE ZONE IMPROVEMENT PROGRAMS

State of Connecticut Dept. of Economic and Community Development monitored program provides tax incentives for manufacturers and certain commercial sector businesses locating within the enterprise zone.

New London's Foreign Trade Zone, located adjacent to the downtown area, is a designated area considered outside the U.S., for Customs tariff purposes.

SITE SELECTION: THINGS TO CONSIDER

Licensing is required for many types of businesses, and the requisite licensing will be a condition of approval for the business opening. If you want to establish a new business in New London, a few questions will need to be answered.

ZONING REQUIREMENTS:

What zoning requirements are required to support the business? Are the locations under consideration zoned for business use? Is the space/property being considered move-in ready, or will it require the construction of a new building or renovation of an existing one?

LAND USE:

Are there any other needs for the business operation that must be met by the site (i.e., lighting, parking, handicap accessibility, drive-through service, etc.) which may need administrative and/or land-use board approval to proceed? A change in the use of a property may increase the parking demand and require a land-use variance if sufficient parking does not exist.

BUILDING REQUIREMENTS:

Is the space under consideration up to code for the proposed use, or will it require an upgrade to be permitted? Construction Permits will likely be required if there will be construction involved with the establishment of the new business.

SIGNAGE:

New London has standards for facade and monument signs. Make sure to review the signed regulations. Are there improvements needed to the signage at the location under consideration? Have you reviewed the town's sign ordinance to determine if such improvements will be acceptable to the town?

HISTORIC PRESERVATION:

Does the location require review by the Historic Preservation Committee?

BUSINESS PERMITS:

Is any permitting/registration required for a home-based business?

ENGINEERING:

Any improvements impacting a public right of way would require a road opening permit through the Engineering Department.



BLIGHT AND PROPERTY MAINTENANCE FAQS

What are some of the responsibilities of property owners in the City of New London?

- 1) Maintain all exterior property and premises in a clean, safe, and sanitary condition.
- 2) Maintain all accessory structures (garages, fences, and walls) structurally sound and in good repair.
- Maintain all sidewalks free from obstructions and hazardous situations. (Bulky waste must follow the Public Works Departments refuse policy, large items such as furniture, televisions, etc. will not be picked up during weekly collection. Snow, ice, overgrown trees and bushes).
- 4) Maintain all premises free from overgrown grass or noxious plant growth in excess of ten inches.
- 5) No inoperable or unregistered motor vehicles that are not stored in an approved structure are allowed. No vehicle at anytime is allowed to be in major disassembly, disrepair, or in the process of being stripped or dismantled unless work is being performed in a structure designed and approved for such use.
- 6) Removal of all graffiti from exterior surfaces of any structure or building.

If I have a concern that my neighbors are not maintaining their property or I have a property maintenance question or complaint, whom do I contact, and can I remain anonymous?

The Building Division is tasked with the enforcement of the Property Maintenance Code and the Blight ordinance for the City of New London. The Building Division is located at 111 Union Street. Office hours are Monday thru Friday 8:30 - 4:00. The Building Division's Main office phone number is (860) 447-5240.

If a complaint can be seen from the public's right of way it can remain anonymous.

TRANSPORTATION

New London has become one of the Northeast's first multimodal transportation centers. All at one location, adjacent to the restored Union Station, are connections for trains, buses, ferries, taxies, and rideshare services.

Rail

New London Union Station, located on the Northeast Corridor, is the busiest railway in the U.S., and is the primary railroad station in southeastern Connecticut. Amtrak trains operate along the Connecticut shoreline between Boston, New York, Washington D.C., and beyond.

Ferry

The New London-based year-round ferry system links New London with Orient Point, Long Island; Block Island, RI; and Fishers Island, NY. 1.3 million people utilize the ferry system annually, with 58 arrivals and departures daily during peak summer travel season.

Highways

New London is ideally situated between many major market areas in the country. By road, New London is approximately 2 ½ hours from New York and less than 2 hours from Boston. New London is also within a 1 hour drive to New Haven, Hartford, and Providence markets. Highway access to interstate I-95 is within minutes from any location in New London. Other major routes serving New London include U.S. Route 1 and State Routes 32 and 85. Additionally, New London is near State Routes 2, 12,156, 184, and 161.

Water Taxi

From June to September the Thames River Heritage Park Water Taxi links downtown New London, Fort Trumbull, and the City of Groton/Fort Griswold.

Air

Groton-New London Airport, across the Thames River 15 minutes from downtown New London, services the business and general aviation demands of our region providing infrastructure and aeronautical support facilities for corporate jets, and multi- and single-engine aircraft operators.

T.F. Green International Airport is 45 minutes away in Warwick, RI.

Bradley International Airport in East Granby, CT, is about an hour and ten-minute drive from New London.

Tweed-New Haven Regional Airport, a public airport, is about a forty-five minute drive from New London.

EDUCATION

New London Public Schools is Connecticut's first and only all-magnet school district. The magnet plan is built upon a three-pathway system.

The district currently serves more than 3,300 students in grades PreK-12 and consists of six (7) district campuses; one preschool, three K-5 elementary schools, one middle school and one 9-12 high school which has three magnet pathways:

- Science, Technology, Engineering & Math (STEM) Pathway
- International Education Pathway
- Visual & Performing Arts Pathway

The election functions of the City of New London are administered by the Office of the Registrars of Voters whose responsibilities and duties are governed by the General Statutes of the State of Connecticut. The Office is administered jointly by a Democratic and a Republican Registrar who are appointed by their respective Town Committees. The principal duties of the registrars are to maintain records of eligible voters, supervise primaries and elections, and uphold the State election laws as governed by the Election Division of the Secretary of the State.
